Tenderers should have a CIDB contractor grading designation of as outlined in the table above. Tenderers must submit their B-BBEE Certificates together with their tender documents in order to be considered for points. Only B-BBEE status level certificates issued by the following are valid:

1. Verification Agencies accredited by the South African National Accreditation System (SANAS); or
2. Registered Auditors approved by the Independent Regulatory Board of Auditors (IRBA) in accordance with the approval granted by the Department of Trade and Industry.

Tenderers must be registered with the CIDB in a CE class of construction works and GB in a class of Building works. Please note that all prospective tenders must be registered on the National Treasury Centralised Database in order to be considered.

Preferences are offered to tenderers who have HDI ownership, undertake to subcontract work to CIDB registered contractors, have a specific CIDB Contractor Grading Designation.
