That:

The Council notes 2024/25 Draft Budget, Schedule of Service Delivery Standards Table and the following budget related policies for 2024/25 Financial Year and recommend that they be tabled before Council for adoption:

- 4. That in terms of section 24(2)(c)(ii) of the Municipal Finance Management Act, 56 of 2003, the measurable performance objectives for capital and operating expenditure by vote for each year of the medium-term revenue and expenditure framework be adopted

To take note that provision was made for a general Increase of 5% on Employee Related Costs and 4 % provision for the Upper limits for Remuneration and allowances for Councillors, implementation being subject to the confirmation by the SALGBC for employees and approval by MEC for Co-operative Governance and Traditional Affairs for Councillors.
- 6. To take note that the Municipal Budget related polices, mSCOA Regulations, Integrated Development Plan, MFMA Budget Circular 128 was observed and taken into account in the compilation of the budget.
- 7. Those copies of the budget are submitted to National Treasury, COGTA, and Provincial Treasury as per the requirements of the MFMA.
